GRAND JURY SERVICE AFFIDAVIT

☐ I affirm that I am **70 years of age or older**. I have attached a copy of my ID as proof of same. I request that the Clerk of Courts remove my name from the list of eligible jurors. **O.C.G.A. §15-12-1.1(b).**

☐ I hereby affirm that I am **not a resident of Rockdale County**. I have attached a copy of my driver's license with my current address or other proof indicating my current address. **O.C.G.A. §15-12-1.1(a)(1).**

☐ I hereby affirm that I am a **full-time student** at a college, university, vocational school, or other post-secondary school and am presently enrolled in classes. I request to be excused from jury duty during the time that I am attending school. I have attached proof of my current enrollment. **O.C.G.A. § 15-12-1.1(a)(2).**

☐ I hereby affirm that I am a **military service member or spouse of a service member** on ordered military duty in service to the United States that requires service member/spouse to be at least 50 miles from his/her home. I have attached proof of active military status. **O.C.G.A. § 15-12-1.1 (c)(2).**

☐ I hereby affirm that I am a **primary teacher in a homeschool** program and that I have no reasonable alternative for the children in the program. I have attached a copy of my Declaration of Intent to utilize a Home School Study Program. **O.C.G.A. 15-12-1(a)(4).**

☐ I hereby affirm that I am the **primary caregiver of a child** six or younger. I have **active care and custody** of said child and have no reasonable alternative childcare available to me. Child's date of birth _____. **O.C.G.A. 15-12-1.1(a)(3).**

☐ I hereby affirm that I am the **primary unpaid caregiver of a person over the age of six** with such physical or cognitive limitation that he/she is unable to care for himself/herself and cannot be left alone. I have attached a doctor's statement supporting the need for care. **O.C.G.A. §15-12-1.1(a)(5).**

☐ I hereby affirm that I have a **documented permanent disability** that would prevent my attendance for jury service. I have attached a statement from a physician which states such a disability. **O.C.G.A. § 15-12-1.1(a)(1).**

☐ I hereby affirm that I am **not a US citizen**. I have attached a copy of my documentation. **O.C.G.A. §15-12-4(b).**

☐ I hereby affirm that I am currently an **elected officer** in State or Local government or held such office within the last 2 years. **O.C.G.A. §15-12-60(b).**

☐ I hereby affirm that I am a **convicted felon** who has not had his/her civil rights restored. **O.C.G.A. §15-12-60(c)(1).**

☐ I hereby affirm that I am currently in a **pretrial release or diversion program**. **O.C.G.A. §15-12-60(c)(3).**

☐ I hereby affirm that I am sentenced under a **conditional discharge** for possession of controlled substance as first offense and certain nonviolent property crimes and have not completed the terms of my sentence. **O.C.G.A. § 15-12-60(c)(4).**

☐ I hereby affirm that I am currently on **first offender** probation. **O.C.G.A. § 15-12-60(c)(5).**

☐ I hereby affirm that I am currently participating in **an accountability court**. **O.C.G.A. §15-12-60(c)(6).**

INSTRUCTIONS

Please provide the documents listed to enable us to process your request for inactivation, disqualification, excusal or deferral. Your request cannot be processed without all required documents.

- **Over age 70** – Provide a completed Jury Service Affidavit with a copy of your ID.
- **Nonresident** – Provide a completed Jury Service Affidavit and attach proof of residence change (New driver's license, lease, utility bill, etc.)
- **Full-time student** – Provide a completed Jury Service Affidavit with proof of current enrollment in school (Enrollment Verification Form, Class Schedule, or Letter from Registrar)
- **Military** – Provide a completed Jury Service Affidavit and attach proof of active military status (Military orders, Letter from Commanding Officer, etc.)
- **Homeschool** – Provide a completed Jury Service Affidavit and attach your current Declaration of Intent
- **Caregiver of child age 6 and under** – Provide a completed Jury Service Affidavit and indicate the child's date of birth
- **Unpaid caregiver of person over age 6** – Provide a completed Jury Service Affidavit and attach a letter from the patient's doctor indicating that they need you as a caretaker for their condition.
- **Medical** – Provide a doctor's excuse that is specific to your inability to perform jury service. It can be a temporary or permanent medical condition as indicated by your doctor.
- **Non-Citizen** – Provide a completed Jury Service Affidavit with a copy of your Permanent Resident Card, Work Authorization Form, etc.
- **Elected Official** – Provide a complete Jury Service Affidavit.
- **Individual who has been convicted of a felony and whose civil rights are not restored** – Provide a completed Jury Service Affidavit with a copy of your ID. Indicate the state in which the felony occurred.
- **Pretrial Release or Diversion Program** – Provide a completed Jury Service Affidavit with a copy of your ID.
- **Conditional Discharge/Possession** – Provide a completed Jury Service Affidavit with a copy of your ID.
- **First Offender Probation** – Provide a completed Jury Service Affidavit with a copy of your ID.
- **Accountability Court** – Provide a completed Jury Service Affidavit with a copy of your ID.
